



135th Annual Michigan Department Encampment

Okemos Conference Center

Okemos, MI

April 27, 2019

The Memorial Service began with a prayer by Acting-Chaplain John Minor. Brother John Minor gave the Chaplain's report (a copy of the report is included in the appendix).

The Encampment recessed at 9:14 AM to prepare for the opening of the Annual Michigan Department Encampment. (hereafter called the "Encampment").

The Encampment resumed at 9:25 AM.

Department Commander Robert Payne called the Encampment to order. Commander Payne instructed the Department Guide to determine if all entitled to remain and instructed the Color bearer to assist him. Department Guide Nathan Tingley reported that all were entitled to remain.

- Lunch will be at 12:15: Lunch tickets are not available today and must have been pre-purchased.
- No Banquet, but a testimonial dinner for Commander in Chief Don Shaw is planned for after the Encampment.

The Proceedings of the 134th Annual Michigan Department were announced as being approved. Moved by DSVC McKinch. 2nd by Dean Lamphere. Passed.

The Committee on Credentials was appointed with L. Dean Lamphere, Jr. PDC as chair with Lloyd Lamphere, Sr., PCC and Steve Martin, CC as members.

The Commander introduced the following National Officers:

National Council of Administration member – Paul Davis, PDC.

Assistant National Counselor Blue Book, Past Commander in Chief, and holder of numerous offices – James Pahl, PCinC, PDC.

The Encampment reconvened at 10:42 AM.

Department Secretary Richard Denney read the report of the Camp at Large report as supplied by Coordinator George Boller. (Report included in the appendix.)

Communications and correspondence

A request for the restoration of rank by Governor Crapo Camp No. 145 for Brother Daniel Vernon Graves who has rejoined Camp No. 145 and the Department of Michigan for the restoration of his former rank of Past Camp Commander. This vote was postponed until the Credential Committee's report. (The request from Brother Graves and the resolution from Gov. Crapo Camp No. 145 are included in the appendix.)

The report from the Credential Committee was prepared. It was declared that all Department of Michigan brother attending were entitled to vote. (Committee report is included in the appendix.)

The request for restoration of Past Camp Commander rank for Brother Daniel Vernon Graves was brought before the Encampment for a vote. Passed.

A proposed amendment was passed at the 137th National Encampment of the Sons of Union Veterans of the Civil War to amend Article V, Section 2b. (A full copy of the Amendment is included in the appendix.)

It was moved Doug Parks to bring the amendment to a vote. A second to the motion was made by Paul Davis. Discussion ensued. A vote was taken with 51 Brothers in favor of approving the amendment and 0 against approving the amendment. Passed. (A copy of the Amendment report is in the appendix.)

Commander Payne read a request from Albert & James Lyon Camp No. 266 requesting assistance for materials for the All Veterans Museum in Escanaba.

A letter from Michael Paquette declaring his intent to be a candidate for the office of Junior Vice Commander in Chief.

A resolution was read to ask for the Encampment's endorsement for Brother Paul Davis announcing his candidacy for the office of Junior Vice Commander in Chief.

Awards

Abraham Lincoln Award. Award will not be presented this year.

The Austin Blair award for the greatest number of members gained was presented to Robert Finch Camp No. 14 by Commander Payne

The Orlando LeValley Award for the greatest percentage of members gained was earned by Russell A. Alger Camp No. 266.

The J. Richard Greene Award for the best Camp Newsletter was presented to Frederick H. Hackeman Camp No. 85 by Commander Payne.

The Encampment recessed so the committees could caucus. 11:12 AM

The Encampment resumed at 11:34 AM.

Reports from the Committees

The Bylaws Committee will report after lunch.

Brother Chuck Worley reported on the Officer recommendations:

Department Commander's recommendations: the primary and parked "suvcwmi"

- 1. The proceeds to help camps with special projects. (\$6486.42) The committee agrees with the recommendation with the stipulation that there are rules and a process for receiving the funds. Approved.
- 2. The proceeds from the permanent fund go into a Michigan Annual Encampment Fund to assist in the funding of the Encampment. (\$1194.27) the committee agrees with the recommendation. Approved.

Dean Lamphere moved to have the recommendations approved at the sound of the gavel if there is no discussion. A second to the motion was offered by Nathan Smith. Motion was approved.

Signal Officer's recommendations:

1. That the Department continue to host its website with Bluehost's web hosting and site backup service, which also includes administering the primary and parked "suvcwmi" domain name variations, at an annual cost of \$180 (to be billed for 24 months 14 august 2019) and renewal of domain names at an annual cost of \$49.

The committee agrees with the recommendation. Approved.

James Pahl rose to a question of information asking if the Signals Officer can change service providers without a vote of the Encampment. The response was no. James Pahl then asked the recommendation be approved with the addition of the Signal Officer has the authority to change service providers should the circumstances deem that necessary. A second to the motion was offered by Keith Harrison. Amended recommendation was approved.

- 2. That enrollment in the cloud based dbBee.com "Standard Plan" be authorized by the Department at the current annual rate of \$83.40, primarily as a replacement of the existing Graves Registration database function. This includes unlimited records, unlimited reports, 30 projects, 1 GB of data transfer per month and full control over report styling. The Communication & Technology Committee would remain the administrative point of contact, including authorization of users. The committee agrees with the recommendation. Some discussion. Commander Payne called for a vote. Motion and recommendation approved.
- 3. That the Department purchase a single-user license for a copy of Nitro Pro 12 PDF solution for the office of the Department Secretary at a onetime cost of \$159.00 as an essential administrative tool for that Office. The committee agrees with the recommendation. Approved.

The Eagle Scout Coordinator Brother Tingley has one recommendation to file a resolution on behalf of the Department of Michigan with the National Organization to change the Job Description of the National Eagle Scout Coordinator. On February 1st of this year the Boy Scouts of America started to let girls into their Scouts, BSA Program with the opportunity to earn the Eagle Scout rank. The change should be made to **CHAPTER III NATIONAL ORGANIZATION**, **Article VII-Officers Job Descriptions & Duties, Section 22.** "The National Eagle Scout Certificate Coordinator shall recognize the advancement of young men belonging to the Boy Scouts of America to the rank of Eagle Scout," to "The National Eagle Scout Coordinator shall recognize the advancement of young men and women belonging to the Boy Scouts of America to the rank of Eagle Scout,"

As this is a resolution, it was moved by Doug Park and seconded by David Rehkopf to refer this resolution the Resolution Committee. Discussion ensued.

The motion to send the resolution to the Resolution Committee was passed.

Brother David Smith reported on the Resolution Committee's findings.

The letter From Brother Paquette, Department of the Chesapeake, seeking the Office of Junior Vice Commander in Chief be acknowledge by the Department Secretary and state that it was read before the Annual Michigan Department Encampment.

The Resolution supporting Brother Paul Davis for the Office of Junior Vice Commander in Chief was approved by the Encampment. Let the record show it was a unanimous vote.

Brother Davis was invited to make a few comments.

James Pahl moved to have the resolution supporting Brother Davis be sent to the National Secretary, Department Commanders, and Department Secretaries.

A second to the motion was made by Dean Lamphere. Motion approved.

Brother Chuck Worley gave the department Council report. (The Council report is included in the appendix.)

Brother Jim Pahl asked Brothers to peruse the display in the lobby from the GAR Hall Museum in Eaton Rapids.

Brother Gosling announced that merchandise would be available during the lunch break.

Encampment broke for lunch at 12:07 PM.

Encampment resumed at 1:01 PM.

Brother David Smith returned with the Resolution Committee's findings on the Eagle Scout language change. The Resolutions Committee recommends the following: This resolution is to be referred to the incoming Department Commander for the creation of a <u>special committee</u> for review and to report back their findings at the 2020 Department Encampment. Passed.

Old business

The Encampment recessed at 3:00 PM.

The Encampment resumed at 3:20 PM.

Commander Payne invited PCinC Ken Freshley to speak on the upcoming National Encampment in Independence, Ohio.

I will continue to have the Annual Department Encampment proceedings published in a timely manner. Included in the review and update of the Department Operating Guidelines is a request for the Department Secretaries budget to be increased by \$50.00. Also Brother Wallace will request an expenditure for Nitro Pro 12 software program for use of the Department Secretary, I ask that this be approved.

Report of the Department Treasurer

Commander Payne, Officers and Brothers of the Department of Michigan

The Department of Michigan has concluded the financial business of the 2018 Membership Year and our finances continue to be positive. We posted revenues and expenditures from normal operations during 2018 of \$4,237.77 and \$2,416.27 respectively to the General Fund. This resulted in an excess of revenues of \$1,821.50 for the year.

Total funds available amounted to \$22,766.76 as of December 31, 2018. Of that total, \$65.42 is restricted for Gettysburg flag replacement and \$182.50 remains in the Greenville Monument restricted account. A total of \$23,986.23 represents unassigned cash that may be disposed of by this Encampment.

The Department of Michigan Permanent Fund reflects a total of \$52,353.74, which consists of a permanently restricted balance of \$51,159.47 and a temporarily restricted income accumulation of \$1,194.27.

I wish to report:

- All permanent fund assets have been invested in government-backed securities or insured certificates of deposit through an Edward Jones account. Stated interest rates on investments are between 2.2% and 3.875% with a net yield of 2.28% on our investment for the year after amortization of bond premiums.
- 2. That the actual expenses incurred for the year were \$3,567.73 under the budgeted amount for the year. This is largely due to officers not submitting requests for expense reimbursements under the Department Guidelines and not having to reorder Department merchandise held for sale. Further, I am investigating an alternate source for our brass kepi badges that will substantially reduce the cost of our merchandise.

I offer these recommendations for consideration by the Encampment for the coming year:

- 1. That the proposed 2019 operating budget for the General Fund, attached to this report, be accepted as presented.
- 2. That the \$29.58 held by the Treasurer from the dissolution of Camp 67 and the \$182.50 restricted funds for the Greenville monument be transferred to the Permanent Fund of the Department of Michigan, Sons of Union Veterans of the Civil War.

I appreciate the trust placed in me by the Brothers of this Department in electing me to the position of Treasurer for this past term of office. I have submitted my name for consideration by the Encampment as Department Treasurer in the coming year. It has been an honor to serve the Department, and continue to be proud to be able to offer my professional skills in this position.

Report Of The Department Counselor

Department Commander Payne and Brothers of the Department of Michigan:

As Counselor I was also part of the Bylaws Committee which is charged with annually reviewing the Department Bylaws and proposing any amendments to those Bylaws. This has been done and recommendations submitted to the Department Secretary.

The Department Operating Guidelines were also reviewed and the Committee provided its recommendations at the last Encampment. Due to time constraints, however, they were not presented to the 2018 Encampment. Changes to the Operating Guidelines must be brought before the Department for either approval or rejection by the membership. This will require action at the 2019 Annual Michigan Department Encampment. Recommendations are completed and have been sent to the Department Secretary.

On a couple of occasions I represented the Department at various activities including installation of Camp Officers and traveling to the Upper Peninsula with Department Commander Payne to install the Officers in Camp 266.

In closing, please note the Department will be called upon to ratify or reject an amendment to the Constitution, per G.O. No 7.

Joint Report of the Signals Officer and Communications & Technology Committee

Brothers of the 135th Annual Department Encampment,

As another Departmental year ends, I want to express my gratitude for the opportunity to serve the Department as Signals Officer and Chair of the Communications and Technology Committee. I am pleased to report that there were no new successful malicious attacks against the Departments' website during the past 12 months. The injected advertising text has been remediated as part of a review of the individual pages and files that comprise the website. Targeted "spear-phishing" email attacks have continued during this past year, and these are most likely a continuation of the post-National Encampment attempts that occurred within 90-days of the encampment hosted by the Department in 2017. Information regarding these attempts has been shared with the National Organization. At the 134th Department Encampment, this office was authorized to pursue the purchase and deployment of an SSL (Secure Socket Layer protocol) certificate to ensure secure connections to the Department's website. I am pleased to report that our hosting provider, Bluehost.com, has provided this certificate to our primary domain, "suvcwmi.org," our "parked" domains, "suvcwmi.com" and "suvcwmi.net," and all website sub-domains, to the Department at no cost.

Going into this administrative year, the primary goal for this Office was to resolve the ongoing issue with the Graves Registration database and search page. The focus was to either repair and upgrade the existing SQL database structure, or to replace it with a suitable alternative. SQL database administrators do not come cheap. In discussions with several, it quickly became apparent that it would be cost prohibitive for the Department to pursue the approach of restructuring and upgrading the existing Graves Registration Database structure using the Structured Query Language format. In searching for a suitable alternative, limited testing has been ongoing through dbBee.com, which is a cloud-based "software as a service" that allows for publishing and maintaining stored data in either a Microsoft Excel Spreadsheet or an MS Access database format. It allows for the creation of searchable forms that can be embed into a webpage. The results have been very encouraging and have been shared with the Department's Graves Registration Officer, Brother Danes. Besides the existing graves "search page" on the Department website, additional specific search pages can be created for the members of the Departments' Graves Registration Committee to use.

During this administrative year, this Office has assisted our esteemed Department Secretary with formatting issues encountered with several PDF forms. This has impacted his performance targets and prevented effective utilization of his time. The "you're only as good as the tools you use" comment has come up in our conversations on several occasions, and we both agreed that proper tools are the backbone of any administrative process. It is simply important to provide the proper and most effective tools for a job.

Based on the above, I have the following recommendations for the 135th Department Encampment:

- That the Department continue to host its website with Bluehost's web hosting and site backup service, which
 also includes administering the primary and parked "suvcwmi" domain name variations, at an annual cost of
 \$180 (to be billed for 24 months 14 August 2019) and renewal of domain names at an annual cost of \$49;
- That enrollment in the cloud based dbBee.com "Standard Plan" be authorized by the Department at the current
 annual rate of \$83.40, primarily as the replacement of the existing Graves Registration database function. This
 includes unlimited records, unlimited users, 30 projects, 1 GB of data transfer per month and full control over
 report styling. The Communication & Technology Committee would remain the administrative point of contact,
 including authorization of users;
- That the Department purchase a single-user license for a copy of Nitro Pro 12 PDF solution for the office of Department Secretary at a one-time cost of \$159 as an essential administrative tool for that Office.

Greetings,

This being my 19th year as Graves Registration Officer for the Department, I submit:

Reiterating my report from past years, the achievements of the Committee, although significant, did not meet the stated goals of previous period's Committee Reports - we were not able to recover all graves related records from all camps, and although we encouraged all camps to appoint an active Graves Registration Officer (CGRO), some camps still fail to do so. The Camps that did not attend meetings during the past year are: 2, 3, 14, 20, 28, 43, 67, 85, 145, 160, 180, 255, 250, 266, and 462. Camps 3, 85, and 250 have not made a report or otherwise contributed in the past few years.

The Committee meets every quarter, realizing our 76th meeting in March of this year, as we achieved an average attendance of over 30% of the total camps in the Department at each meeting. These meetings created meaningful dialog that is useful to Camp Graves Registration Officers (CGRO) and allowed them a forum to express ideas, concerns, and to spend time teaming about the resources available to them.

Each CGRO that attends a quarterly meeting receives an updated copy of the complete department database which is used in their research and in sharing information with the public. That database has reached 74,938 records (an increase of over 460 in the past year) of heroes buried both in Michigan and in outstate locations. This officer has also undertaken the task of reconciling all entries both in the National and department databases.

In addition, the Committee continues its work on the "Last Soldier" project, created by Member Jim Petrimoulx from Camp 67. We hope to publish this list as part of the Graves Registration section of the Department Website, with Camps reporting changes to the department Officer.

Under the Department Commander's leadership, the Department of Michigan Graves Registration Program continues to flourish, and remains a program second to none in the National Organization.

A total of 14 certificate applications have been reported and processed from this office from many SUVCW Camps in the Department. Currently this office holds in care for the Department of Michigan 12 Eagle Scout Certificates. I would encourage all Camps to keep 10 certificates on hand at any given time so that they are able to process any applications they would receive without delay of mail.

Recommendations,

1. File a resolution on behalf of the Department of Michigan with the National Organization to change the Job Description of the National Eagle Scout Certificate Coordinator. On February 1st of this year the Boy Scouts of America started to let girls into their Scouts, BSA program with the opportunity to earn the Eagle Scout rank. The change should be made to CHAPTER III NATIONAL ORGANIZTION, Article VII – Officers Job Descriptions & Duties, Section 22. "The National Eagle Scout Certificate Coordinator shall recognize the advancement of young men belonging to the Boy Scouts of America to the rank of Eagle Scout,..." to "The National Eagle Scout Certificate Coordinator shall recognize the advancement of young men and women belonging to the Boy Scouts of America to the rank of Eagle Scout,..."

Report of the G.A.R. Records Officer Department of Michigan Sons of Union Veterans of the Civil War April 27, 2019

Commander Payne, Officers, Delegates and Brothers,

Another years has come to a close. The work of the G.A.R. Records Officer, and the Committee, moves forward. But, it only moves forward with the assistance of all Brothers.

There are a few brothers whom I must single out for their assistance and willingness to notify this office when they come across the locations of previously unknown records from Michigan G.A.R. Posts. Brother Bruce Butgereit is always on the lookout for records in his travels, and he always finds something. His finds include:

The charter for the O.M. Poe Post No. 433 of Detroit is at the Detroit Historical Society; additionally, they have several other items identified online but most are images of the building, a few photos of the men, and other miscellaneous items. It is very likely there is more in their collection that has not been scanned.

The Clarke Historical Library in Mt. Pleasant hold the records from the Billy Cruson Post No. 347 of Breckenridge, Michigan. Records include reports, membership records, receipts, correspondence, books and miscellaneous items, as well as records from the Women's Relief Corps No. 95, also of Breckenridge.

The Clarke also holds the family papers of Major Amasa Brown Watson, including biographical materials, family correspondence; business correspondence, mostly related to lumber and timber; the Republican National Convention, 1888; the education of his nephews at the Michigan Military Academy (Orchard Lake, Mich.); General Orders, 1861; and after his death, his wife's correspondence related to the building of his mausoleum, and miscellaneous papers related to the Amasa B. Watson G.A.R. Post No. 395 of Grand Rapids, Michigan.

Brother Tom Bruce of Camp No. 20 is always working on a project for the Order, and continues his search for members of various posts.

Brother Gary Swain, Past Commander of Camp No. 20, notified this office of the discovery of the parade banner of the James F. McGinley Post No. 201 of Manistee. The banner is on display in the Historical Society museum in downtown Manistee. Unfortunately, the staff of the museum had no clue what it was, or that it was even on display.

The Robert Finch Camp No. 14 newsletter, The Sharpshooter" recently featured the news about the possible location of the Israel Richardson Post No. 13, G.A.R. Hall in Harbor Springs, Michigan. The fact that between the two second story windows it says "G.A.R.", is pretty convincing. This hall's location and a photograph will be added to our information, and in the future, the photos of all surviving G.A.R. Halls will be added to the Department website.

In the past year, as always, several inquiries have been received by this office. Most are requests for information on a comrade of the Grand Army, or a soldier or sailor who served from Michigan. Interestingly, most inquiries come from persons who are not members of the Allied Orders. I have made it a practice that when the information is communicated to the person, I also state that they must truly be proud of their ancestor's service, and that they have an opportunity to honor their ancestor by joining the

Sons of Union Veterans, the Daughters, or one of the other Allied Orders. Most times they ask for the information and I am able to put them in contact with a camp or tent in their area.

As always, it is an honor to serve the department in this capacity, and I look forward to continuing the work

Greetings,

This being Monuments and Memorials Officer for Son of Union Veterans of the Civil War, I submit:

Over the course of the year, I have regularly reported about the ongoing battles over the interpretation and status of Civil War monuments, seemingly at times though, as a statue is removed, a new one may go up and over the past several years, in cities and on college campuses across the nation, Civil War statues and monuments have been removed or relocated, steps often prompted by an ignorance of history or an impassioned debate on current issues.

The ongoing saga of Grant's House in Detroit

One local story out of Detroit is the relocation of Presidents Ulysses S. Grant's house in Detroit. As it stands now, in the bedroom of the Detroit house where Civil War hero and U.S. President Grant lived in the mid-1800s, there's now a dirty waterbed and plywood covers the windows of the two-story white clapboard house at the former Michigan State Fairgrounds near Eight Mile and Woodward. Grant lived in the house as a young officer prior to the Civil War. The historic home, which was moved to the fairgrounds in 1936, is in disrepair, with holes in the walls and piles of trash in rooms. However, over the past few years, plans are in the making to move the home of the 18th president of the United States to the Eastern Market area near the Dequindre Cut pedestrian and bicycle path. It would be renovated to become an education center run by Michigan's Department of Natural Resources, said Sandra Clark, director of the Michigan History Center in Lansing. Once relocated, the remodeled home would have some historical programming and serve as a community space.

And because it would be located in the Eastern Market district, there could be a garden aspect, too. "Grant had a kitchen garden. We'd like to have that," Clark said. For years, historical preservationists and others have attempted to find a way to restore and find a new location for Grant's home. It is still unclear as of today whether the new plan will become reality.

"It's one of the oldest surviving structures in the city of Detroit," said Dan Austin, author of several books about Detroit history and founder of the website HistoricDetroit.org. Grant is one of three presidents known to have lived in Michigan. The others are Gerald Ford and George H.

W. Bush, who was stationed briefly at Naval Air Station Grosse IIe at the end of World War II.

The core idea is to move the home to the city's Eastern Market area at the Wilkins Street bridge, which is next to the Dequindre Cut. The DNR runs another education center nearby on Detroit's downtown riverfront. Officials for Eastern Market Corp. and the state's Michigan Historical Commission — which advises the DNR — confirmed the plans but stressed that funding and other approvals have still not been finalized.

As quoted back in 2017: "I hope we can say something publicly by the end of the month," said Dan Carmody, president of Eastern Market Corp. "This is a complicated deal with a lot of moving parts."

Grant, who was born and raised in Ohio, lived in the home with his wife, Julia Dent, from April 1849 to May 1850. It was built either in 1836 or 1837 — historical references differ — and its original location was at 253 E. Fort, near Russell and Rivard streets in the area now known as Lafayette Park. At the time Grant lived there, military barracks were located at Russell and Clinton. The home was saved from demolition in 1936 when the Michigan Mutual Liability Co. insurance company bought it and presented it as a gift to the fairgrounds. The home was relocated in 1958 within the grounds to its current spot. It was open to the public for years but it eventually was closed and mainly was used as storage facility, Clark said: "That's how that waterbed somehow got in there," she said. Historical items from the house were moved to the historic Fort Wayne when the state fairgrounds closed.

So far as to date, efforts to find new life for Grant's home have not succeeded. There still are talks to move the home to either Belle Isle or Historic Fort Wayne since Greenfield Village declined an offer to take control of the home several years ago.

As far back as 2015, the state and Eastern Market thought they had a deal to move the house to the Detroit Edison Public School Academy's campus on St. Aubin, near Gratiot. That's also near Dequindre Cut and close to the site for the current plan, but that didn't pan out either.

Currently, the state fairgrounds is still in the process of a change in ownership and the debate with the city of Detroit is ongoing. I will continue to follow up on this issue.

"The Missing Cannon in Prospect Park"

A more recent issue of concern is the latest report from Camp 427's member Gary Prichard whom forward to me his concerns about the missing Civil War era cannon in Prospect Park. The Cannon in Prospect Park (Corner of Prospect and Cross Streets in Ypsilanti) stands guard in Prospect Park is the largest cannon in the State of Michigan. The weapon was cast at West Point Foundry in 1865 and taken to Fort McClery, Kittering, Maine and mounted as a coastal defense gun. There in 1901 Ypsilanti Mayor Oliver Thompson admired it and learned it was to be replaced so he decided to apply for it on behalf of the city and after two years of correspondence, the cannon arrived at the depot in October of 1902. On the advice of Mayor Thompson it was given to the Carpenter Post of the G.A.R. and John Engel hitched eight horses to the wagon and moved the weapon to the base of Cross Street hill, but because of the weight, could go no further. A stonecrusher with tractor wheels was used to carry the gun up the hill. The cannon was set in place on October 13, 1902. However, no one can now recall when the cannon has been removed and according to Gary, after he called the city, he was told that the cannon was probably temporarily moved so the city can complete several upgrades to the park. I plan on following up on this report and see if there are any more definitive answers.

Finally, I will continue to report one the recent and ongoing phenomenon of vandalized monuments and memorials. How are we to deal with people who are more intent on tearing down history rather than building on it? People who are more interested in destruction than education?

This recent phenomenon of destroying historical statues and markers continues to spread across the country like a plague. And it's no longer confined to memorials dealing with the Civil War. Everything from the Joan of Arc statue in New Orleans to the William Lee (father of the U.S. Airborne) statue in North Carolina has been vandalized. Even the Peace Monument in Atlanta has been vandalized. We must do what we can to be vigilant and stop this sickness dead in it's tracks.

It is suggested that modern, affordable and rugged surveillance video cameras could be used to capture the crimes along with building up alliances with local authorities and civically active crime stopper groups. It is increasingly disappointing to hear of these historic monuments, statues, landmarks and a murals vandalized with spray paint or being demolished by gangs. Not to mention the significant amounts of trash that is now being left behind following regular holiday weekends. These monuments, often 90-100 years, are all that is left of our history and family records. We should not leave them destroyed, we should repair or replace them.

For the administrative year of 2018-2019, your Department Council approved several items for the benefit of the Department of Michigan operations. The first of these was to approve an advance of \$1250.00 for the Encampment Committee to use for securing the 2019 Department Encampment site and other down payments. The expectation is that these funds would be paid back to the treasury and a line item budget would be added for future Encampments.

The Department Council was also asked to approve a change of Brothers approved to endorse checks and other instruments to conduct the business of the Department of Michigan. Removed, as signatories are Brothers Brian Shumway and Max Newman. Added, as signatories are Department Officers, Brothers Richard Denney and Charles Worley. The Council concurred that Brother Worley would not endorse any checks written to himself or pertained to a Council decision that he voted upon in order to avoid a conflict of interest.

With the decision made to dissolve the Allied Orders Encampment/Convention Committee, the left over funds needed to be divided. The Department Treasurer's 4^{th} quarter/Year to Date balance sheets and proposed budget for 2019 have been reviewed and appear to be in good order.

The Camp shall be constituted and remain constituted as provided by the Constitution and Regulations (C&R) governing the National Organization, Sons of Union Veterans of the Civil War, and shall be known as the Department of Michigan SONS OF UNION VETERANS OF THE CIVIL WAR. The Department is organized as an unincorporated association under the laws of the State of Michigan. The organization is organized exclusively for charitable, religious, educational, and

scientific purposes under section 501(c)3 of the Internal Revenue Code, or corresponding section of any future tax code.

Section 2: ACTIVITIES NOT IN FURTHERANCE OF EXEMPT PURPOSES:

No part of the net earnings, if any, of this unincorporated association, shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the unincorporated association shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c)3. No substantial part of the activities of the unincorporated association shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the unincorporated association shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these by-laws, the unincorporated association shall not carry on any other activities not permitted to be carried on (a) by an unincorporated association exempt from federal income tax under section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an unincorporated association, contributions to which are deductible under section 170(c)2 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Section 3: SEPARATION, DISSOLUTION AND DISPOSITION OF ASSETS:

In the case of surrender or forfeiture of the Department Charter, all Deartment property and assets shall be turned over to the National Commander-in-Chief of the Sons of Union Veterans of the Civil War via the Department Commander of the affected Department acting as his duly authorized representative to collect and hold all such property in trust for the National Organization, Sons of Union Veterans of the Civil War, an organization exempt from taxes under section 501(c)3 of the Internal Revenue Code.

Section 4: All property of the Department shall be held for the National Organization, Sons of Union Veterans of the Civil War, as a charitable trust that is held and used for the purpose for which the Order exists. Any such transfer or disposal within six months of disbandment or surrender of the Department Charter without the written consent of the National Commander-in-Chief of the Sons of Union Veterans of the Civil War is prohibited. The property and funds of the Department shall not be divided among its members.

Section 5: In the event the National Organization, Sons of Union Veterans of the Civil War, no longer exists, said property and funds shall revert to the benefit of the first and any remaining organization of the Allied Orders of the Grand Army of the Republic or in their absence, to the State Archives of Michigan.

Section 6: Notwithstanding the above language, upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within

the meaning of section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.

Operating Guidelines Review and Recommendations the Department of Michigan, SUVCW

Per direction from the Commander Smith dated 30 July 2017, a special Committee was appointed to Review and make recommendations concerning the Operating Guidelines for the Department of Michigan as well as some other considerations listed below.

The review of the Operating Guidelines indicated there were instances where any changes to the Bylaws may also require changes to the Operating Guidelines and vice versa in order to ensure compatibility between the two documents.

The Committee completed its review and the results were approved by Department Commander Smith. Due to the amount of business transacted at the 134th Annual Michigan Department Encampment, these changes to the Operating Guidelines were not presented to the Encampment at that time. The requirement for approval of these proposed changes requires they be posted for review at least 60 days prior to the 135th Annual Michigan Department Encampment and then acted upon during the 135th Annual Michigan Department Encampment.

As a result, the Operating Guidelines Review Committee brings to this Encampment certain matters for your consideration so as ensure compatibility and eliminate any conflicting language between the two documents.

The Commander's directive:

Part 1: Review the Department Operating Guidelines and propose any modifications or additions as recommended by the committee.

This part of the report is centered on any changes to the Operating Guidelines as well as any changes that may be required in the Bylaws so as to be in line with and not conflict with, or be ambiguous when considered singly or together.

Methodology:

To ascertain if the current Department Operating Guidelines and any proposed changes are also, in compliance with the current Department and National Bylaws, both documents were consulted to ensure the proposed/revised Department Operating Guidelines were also in compliance.

The evaluation process, also includes those items to be addressed by the Bylaws Committee at this 2019 Department Encampment.

Please also note that an extensive search was made of the National and Department Bylaws, the Department Guidelines for the past versions and also any other documentation or historical references including Department and National Proceeding and any and all relevant documentation such as financial reports.

In addition, the National Counselors have been contacted for their advice and counsel in these matters.

Proposed Changes: Operating Guidelines

Paragraph 2. The portion of each A Camp's delegate representation to the Annual Michigan Department Encampment Intis based on that portion—membership shall be based on of the Camp's membership as of March 31st and its having filed Form 27 (Camp Annual Report) with the Department prior to the Annual Michigan Department Encampment. Any Camp that does not file its Form 27 prior to the Annual Michigan Department Encampment will have its delegate representation based on the most current Form 27 on file with the Department. The current Camp Commander and past Camp Commanders are in addition to the delegate strength based on Camp membership described above.

The portion of the *The* Department's delegate representation to *the National Encampment* that is based on membership *and* will be determined by the Department Annual Report (Form 35), which shall be compiled from all the Camps Form 27 (Camp Annual Reports) on file with the Department as of May 1st (Form 35 is due at the National Organization on or before the last day of May). *The current Department Commander and past Department Commanders are in addition to the delegate strength based on the Department membership described above.* Passed.

Delegates to the National Encampment shall be elected at the Annual Michigan Department Encampment. Those brothers attending a National Encampment who have not been elected a Delegate shall be designated as Alternate Delegates and may upon approval of the Department Commander be seated as a Delegate to replace an Elected Delegate who is not in attendance. Passed.

Paragraph 5: Dress Code

For Reference: The Current Dress Code follows:

5. While the Department of Michigan shall have no required dress code, the Department shall have an optional dress guideline for all Camps within the Department. The dress shall include a hat of Civil War-period Union Army kepi style, dark wool, blue in color, with a leather bill. The kepi may be decorated with any of the following: a hat badge consisting of an open top wreath encircling the letters "SUV" of gold color, affixed to the front center of the kepi, a Department of Michigan Cap Mark of the Civil War Union Army Corps Style, consisting of a crescent moon over a five point star, affixed to the top center of the kepi. The VII Corps Cap Mark shall be red with optional gold edging and silver star. The jacket shall be civilian or a Civil War-period Union Army four button fatigue blouse (also known as a sack coat), dark blue in color, with (optional) affixed to the right collar the letters "MICH" and affixed to the left collar the letters "NO." followed by the member's Camp number, ó " in height, all of gold color. Dress style slacks of dark blue or black color, a dress style shirt, solid white in color, a necktie of subdued color or preferably of the SUVCW badge or crest pattern and leather dress style shoes of black or brown complete the dress.

White dress gloves also may be worn. The above is a guideline and shall not be construed to be a required dress of any Brother.

The following is recommended and would be placed before the text above.

The Department of Michigan has no required dress code. The Department has an <u>optional</u> dress guideline for all Camps within the Department as follows:

The dress *guideline may* include a hat of Civil War-period Union Army kepi style, dark wool, blue in color, with a leather bill. The kepi may be decorated with any of the following: a hat badge consisting of an open top wreath encircling the letters "SUV" of gold color, affixed to the front center of the kepi, a Department of Michigan Cap Mark of the Civil War Union Army Corps Style, consisting of a crescent moon over a five point star, affixed to the top center of the kepi. The VII Corps Cap Mark shall be red with optional gold edging and silver star. The jacket shall be civilian or a Civil War-period Union Army four button fatigue blouse (also known as a sack coat), dark blue in color, with (optional) affixed to the right collar the letters "MICH" and affixed to the left collar the letters "NO." followed by the member's Camp number, ó " in height, all of gold color. Dress style slacks of dark blue or black color, a dress style shirt, solid white in color, a necktie of subdued color or preferably of the SUVCW badge or crest pattern and leather dress style shoes of black or brown complete the dress. White dress gloves also may be worn. The above is a guideline and shall not be construed to be a required dress of any Brother.

Generally, the dress guideline for the Annual Michigan Department Encampment shall be business casual attire including sport coat and slacks or suit with shirt and tie.

The Camps being more casual in their meetings, may determine what is appropriate dress for its Camp meetings and activities. Passed.

Paragraph 6: "A discounted pre-registration fee for Camp delegates to the next Department Encampment will be \$5.00 per person. Anyone pre-registering less than 7 days before the Department Encampment will be charges \$10 per person."

Change as follows:

A pre-registration fee for Camp delegates to the **Annual Michigan Department Encampment** will be \$5.00 per person. Anyone pre-registering less than 7 days before the **Annual Michigan Department Encampment** will be charged \$10 per person.

Present and Past National Officers shall be exempt from paying the Encampment Registration Fee. **Brother Jim Pahl moved to insert the word "elected" between the National and Officers.** A second to the motion was made by Brother Terry McKinch. **Motion was passed.** Paragraph 6 was rhen passed.

Paragraph 7: "Annually Budgeted Authorized Expenditures: Annually budgeted authorized expenditure limits allow for reimbursement for the below listed officers and committees will appear in the Department's annual budget. Approved expenditures would typically include: Long distance phone calls, postage, mileage, supplies, etc.; but would not include such expenditures as: equipment, lodging, meals, etc. Requests for expenditures

above budgeted limits shall be made in advance of such expenditure to the Department Treasurer, who in conjunction with the Department Council, shall review the request and

make a recommendation to the Department Commander, who will either approve or reject the recommendation. All requests for reimbursement of expenses shall be accompanied by documentation of expenses incurred."

Change as follows:

Annually Budgeted Authorized Expenditures: Annually budgeted authorized expenditure limits, allowed for reimbursement for the below listed officers and committees, will appear in the Department's annual budget. Approved expenditures would typically include: Long distance phone calls, postage, mileage, and supplies, etc.; but would not include such expenditures as: equipment, lodging, meals, etc. Requests for expenditures above budgeted limits, shall be made in advance of such expenditure to the Department Treasurer, who in conjunction with the Department Council, shall review the request and make a recommendation to the Department Commander, who will either approve or reject the recommendation. If the request for funds is made by the Department Commander, the Department Council may either accept, modify of reject the request. All requests for reimbursement of expenses shall be accompanied by documentation including actual receipts for all expenses incurred.

Paragraph 9: Officers and Committees who maintain Department Records (databases, spreadsheets, word processing documents, etc.) in an electronic format on their computers shall provide the Department Signals Officer with an electronic copy of those records 30 days prior to the annual Department Encampment. The Department Signals Officer will post (via FTP) the submitted electronic records in compressed format to the Michigan department allocated server space on the National SUVCW Server.

Change As follows:

Officers and Committee Chairs who maintain Department Records (databases, spreadsheets, word processing documents, etc.) in an electronic format on their computers or other electronic devices shall provide the Department Signals Officer with an electronic copy of those records 30 days prior to the Annual Michigan Department Encampment. The Department Signals Officer shall collect these files and create a suitable backup copy for archival purposes using a standard format such as a .pdf file. Brother Keith Harrison moved to insert the words "and the Department Secretary" between "Department Signals Officer" and "with". Brother Steve Williams seconded the motion. Motion passed. Brother Keith Harrison moved that Paragraph 9 be submitted to the Communications and Technology Committee for recommendations on electronic mail and records. Brother Nathan Tingley seconded the motion. Motion passed.

Paragraph 10: "The Department Commander will appoint the appropriate number of Brothers to serve on the Allied Orders Department Encampment Site Committee."

Change as follows:

Insert/Add: "The Department Commander will appoint the appropriate number of Brothers, being no less than three, to serve on the Annual Michigan Department Encampment Site Committee."

Insert/Add: The Annual Michigan Department Encampment Site Committee shall select the time and place for the Annual Michigan Department Encampment and report their findings to the Department Commander before May 1st in any year.

Insert/Add: In the event of the failure of the Site Committee to fix the time and place of the Annual Michigan Department Encampment before May 1st, the time and place shall be determined by the Department Commander, Secretary, Treasurer and the members of Council; by a majority vote of those present at a meeting; duly called by the Commander at least 30 days prior to June 1st in any year. A change in the Department Bylaws prompted a change in Paragraph 10 to: The Department Commander will appoint the appropriate number of Brothers being no less than three to serve on the Annual Michigan Department Encampment Site Committee.

The Annual Michigan Department Site Committee shall select the time and place for the Annual Michigan Department Encampment and report their findings to the Department Commander before February 1st in any year.

In the event of the failure of the Site Committee to fix the time and date of the Annual Michigan Encampment before February 1st, the Department Commander shall

appoint a committee of Three Brothers to provide a recommendation by March 15th in any year for three dates and 3 locations to the Department Commander for hid decision as to selecting and the time and location of the Annual Michigan Department **Encampment.**



During your assembly and meeting at the annual encampment, I am humbly asking to have my previous rank of Past Camp Commander restored. At my request, I was honorably discharged from Gov. Crapo Camp in 2006. At the time, it seemed with full-time hospital employment and serving our country / community, time and resources seem too short.

Brief History:

Already being a licensed EMT, I entered the U.S. Coast Guard Auxiliary in Nov. 1997. This decision was a direct result of the Coast Guard Authorization Act of 1996. At Station Saginaw River, I served on a reserve schedule from April 1998 through Jan. 2005. At this time, I took an inactive roll so I could enter reserve law enforcement. On Jan. 20th. 2005, I started with the Shiawassee County Sheriff's Office as a reserve deputy. I stayed here until Sept. of 2012. In Jan. 2013, I returned to my previous CG command until August 2013. In December 2013, my resume was accepted at the Clayton Township Police Department. I began serving here as a reserve police officer in April of 2014. I still serve here, mostly augmenting the night shift road patrol. All of this occurred while being employed full-time at McLaren Regional Medical Center in Flint. In January 2018, I separated / retired from the CG Auxiliary with 19 yrs, 4 months and 8 days credited service. On December 7th. 2018, I retired from McLaren Hospital with 43 years of service. I would like to remain with CTPD a few years yet.

Department report of Voting on Proposed Amendment to the SUVCW Constitution

Voting on Proposed Amendment to the SUVCW Constitution

At the 137th National Encampment of the Sons of Union Veterans meeting in Framingham, Massachusetts 10-11 August, 2018, at which a quorum was present throughout, and the required majority of such delegates voted in favor to amend Article V, Section 2b of the National Constitution of the Sons of Union Veterans of the Civil War as follows:

Article V, Section 2b. If the Commander-in-Chief is of the opinion that an action of the last proceeding any National Encampment is in violation of or in conflict with our Congressional Charter, and/or the Constitution, and/or National Regulations, and/or United States Law, and/or any State's Law, he may propose such General Order(s) to delay implementation of such action or suspend such action if previously implemented, until such time as the violation or conflict can be corrected. A two-thirds majority vote of the Council of Administration is required to support the proposed General Order authorizing the Commander-in-Chief to proceed, the Commander-in-Chief abstaining from participating in such vote and the Senior Vice Commander-in-Chief may only vote to break a tie. Such presentation and vote may be taken by electronic means of communication. The Commander-in-Chief must propose a resolution to the conflict by the next National Encampment.

This change clarifies the Commander-in-Chief's authority to take action to suspend or delay the implementation of an action taken by any National Encampment rather than just the last National Encampment, and includes State Laws as well as United States Laws. The process for taking such action by the Commander-in-Chief remains the same

As contained in Article IX of the Constitution, this amendment cannot be effected until favorably acted upon and ratified by at least by 50% of the departments.
