#### LONG MAY IT WAVE!

# Department Orders #1



Series 2011 – 2012

In order to allow for the smooth implementation of Commander in Chief Schall's General Order No. 20, concerning filing requirements for Sesquicentennial Signature Events, the Department of Michigan will require all Camps within the Department applying for this designation, to submit applications for this status at least 40 days before the event.

Note: I am requiring an extra 10 days because we need to be sure that the processing on our end is done, and thus our Camps will not run afoul of the General Order. The mode of transmittal of this paperwork is largely by use of the U S Postal Service. If your paperwork goes into the U S mail, it takes time to get the application to Department Headquarters. Once I get it, I can have it reviewed and into the mail on the next business day, but it will take the Post Office a little more time to deliver it. This extra ten days is meant to make sure that your submission will not be rejected because of the time it takes to get things through the mail. You are putting a lot of effort into these events. I don't want anyone to loose their chance for this designation because the mail made them run afoul of the General Order.

It is extremely important that <u>each Camp designate one person as a contact for the receipt and transmission of electronic communication.</u> If neither the Camp Commander nor the Camp Secretary are able to fill this role, please ensure that each Camp designates a focal point to satisfy this need and notify the Department Secretary of same.

At the 122<sup>nd</sup> Department Encampment, we launched a new program designed to assist Camp Secretaries in the performance of their duties and responsibilities for managing and meeting deadlines and accuracy in using and filing the various reports required of the Camps. This program includes concise instructions, a list of deadline dates, parties to whom forms and documents should be sent. A set of approved electronic files which includes the nine most commonly used Camp Forms including Forms 2, 3, 4, 6, 9, 10, 22, 27a, and 30 have been supplied on a CD along with samples of each Form to illustrate how they should be completed.



During the Department Encampment, all Camps in attendance received an envelope with all of the program components. Those Camps who were not in attendance will receive their program via regular mail shortly.

Please embrace the desires of Commander in Chief Schall and Department Commander Shaw and use the Forms and training program provided.

# Sons of Veterans Reserve of Michigan

The Michigan Sons of Veterans Reserve Company finished 2010 with a bang and has begun what is shaping up to be a busy 2011

This past November a detachment of the SVR Company traveled east to participate in the annual Remembrance Day weekend activities in and near Gettysburg, PA. On Friday the Company was fortunate enough to have taken part in a tour of the fields at Fredericksburg and Chancellorsville as presented by our National Park Service guide. The Brothers marveled at his knowledge and insight of these actions and were lucky to have seen many of the more obscure places not usually open to park visitors. Saturday is always the busiest day for the Wolverines. The first formal activity of the Company was joining with our fellow SVR Brothers and representative members of the other Allied Orders at the Albert Woolson Monument for a brief service. We then rallied at the Parade staging area where we joined with members of the 27th Indiana, a fellow Company of the 3rd District, and participated in the very lengthy parade through Gettysburg onto the grounds of the National Park. After breaking ranks we formed at the Michigan Sharpshooters Monument on Little Round Top to support the Department's memorial service. Shortly afterwards our own Jentery Farmer was initiated into the Order on Little Round Top and became a Brother of the Company. We then made our way to what has become an annual gathering at General Pickett's Buffet. There we joined with family members, fellow Sons and members of the other Allied Orders of Michigan and MOLLUS. Some of us made the observation that when we first started participating in this activity the restaurant staff pushed together a couple of tables for us to eat together. 2010 found us occupying a wall of tables and then some. It was a true testament to the desire of the Wolverines to do honor to those of Michigan who fought and fell to preserve our Union. On Sunday the Company again rallied and visited several points of the Gettysburg Battlefield seeing some of the more difficult to find often overlooked areas of the park before beginning the long trip home on Monday.

2011 has brought some interesting activities for the membership. In April the Company conducted its annual training weekend for our newer troops and a few folks new to the reenacting hobby. This year's session was unique in that it was conducted in a state park on the shores of Lake Huron. The troops were billeted in a primitive state cabin on the grounds.

Also in April representative members of the Company again travelled to Springfield, IL where it took part in the annual Lincoln Program.

In May a few members of the Company supplemented the Camp Guard of the Robert Finch Camp No. 14 during a unique headstone dedication program for two Native American soldiers who were laid to rest at Boyne City, MI.

Upcoming activities include assisting the LeValley-Heusted Camp No. 255 of Mayville, MI with a service honoring Orlando LeVelley, Michigan's last American Civil War Veteran on July 23. We are preparing for a headstone dedication service for the ancestors of one of our own members. The Company is looking forward to participating in the September 19th memorial service honoring the last Civil War Veteran of Northeast Lower Michigan and his father, both of whom enlisted and served together in the 5th Pennsylvania Cavalry and were laid to rest near each other at Lincoln, MI. It appears probable the Company will again support the Department with the Veterans Day effort in Detroit on November 5th. The November 18<sup>th</sup> -20<sup>th</sup> Remembrance Day journey is expected to also include tours of the fields of Spotsylvania and North Anna River.

The adverse impact of the increasing cost of travel is emphasizing the need to expand the Company's membership base. The Brothers of the company bear the own travel costs driving from their homes to function. For example, one ceremonial activity in Michigan in 2010 had the assisting Brothers driving from between 100 and 450 miles to support a program that lasted about an hour. The Brothers freely do this without complaint but there are just so many such things they can support every year. Not everyone is expected to attend every available activity. Increasing our membership with an ever larger pool of trained and equipped members, more representative of the area we serve will make supporting our Camps and Department at their functions a load far easier to bear.

Membership in all Sons of Veterans Reserve elements is opened to all Brothers of the Order in good standing, be they Members, Associates, Juniors or Junior Associates who are interested in the military aspect of our Order. Our basic mission is to engage in activities intended to help "...keep green the memory..." of those that fought and fell to preserve our Union. Where possible we will endeavor to also support functions of the Department, its Camps and the other Allied Orders. Dues remain at the bare minimum.

At the conclusion of the service the camp moved to historic Oak Hill Cemetery in Pontiac and the grave site of namesake General Richardson. The memorial service was highlighted by the stirring biography of the general delivered by Brother Chip Tischer and the placing of appropriate floral tributes.

Memorial Day 2011 was our duty and honor and we had fun doing it.

## Henry E. Plant Camp 3

This Spring the Henry E. Plant Camp #3 has become a very busy camp. We have started a couple of big outside projects. One is working on naming the US 31 bypass (US 231) after our namesake Medal of Honor Recipient Henry E. Plant of the Nunica area, whose farm at 120<sup>th</sup> Avenue and Leonard is on the US 231 route. Camp Commander Richard Scott has appointed a three member committee of John Scott (Chairman), Daniel Grable and Max Rieskie to work on this project.

Our camp's second project is working on the replacing of the Noah Perkins Post #279, Grand Army of the Republic monument in the Spring Lake Cemetery that was vandalized in 1989-1990 and replaced with a tombstone monument with the same information as the original monument. Currently we are trying to find a picture of the original monument.

Meanwhile the brothers of the camp has donate an engraved fundraising memorial brick to be placed at the base of the Fallen Veterans Monument in Grand Haven's Central Park The Fallen Veterans Monument covers fallen veterans from the area north of the Grand River/M-45 in northern Ottawa County since World War II. Two brothers of our camp Ken Kelly and Max Rieskie chair the Monument committee. Along with our Camp Commander Richard Scott as a committee member. The engraved statement is "To our heroes, Camp #3, SUVCW.

On Friday May 6<sup>th</sup> the camp conducted a Civil War School Presentation for the 8<sup>th</sup> graders in the Harbor Light Middle School, West Ottawa School District in the Holland area. We had the President Abraham Lincoln re-enactor appear who works at the Henry Ford Museum in Dearborn and appears at the Holland Museum's Civil War muster as part of the presentation. President Lincoln gave a presentation on his life. Also appearing during the presentation was U. S. Congressman Robert Dale Owen of SW Indiana ancestor of Henry E. Plant Camp's brother Clifford Owen who portrayed the Congressman. Along with the President and Congressman the camp provided a Presidential Honor Guard for the event. The Honor Guard members consisted of Captain Richard Scott, Jonathan Scott and Daniel Grable.

Memorial Day Weekend found the camp very busy. On Saturday the Camp attended the dedication of the Muskegon County Medal of Honor Recipients plaque located in the Veterans Memorial Park in Fruitport. The Plaque placement was Co-Chaired by our PCC Max Rieskie, Commander of the VFW Polar Bear Post #3734 of Fruitport. The Medal of Honor recipients included Civil War veteran Corporal Alexander U. McHale of Company H, 26th Michigan Infantry and Korean War veteran Corporal Duane Dewey of U. S. Marine Corps Reserve Co. E, 2<sup>nd</sup> Battalion, 5<sup>th</sup> Marines, 1<sup>st</sup> Marine Division (Reinforced). Both of the veterans served from Muskegon.

During the ceremony Brother Max Rieskie read the citation of Medal of Honor Recipient Dewey. Mr. Dewey, one of two living MOH recipients in the State of Michigan, then spoke on his actions in Korea. Later LTC (Ret.) Max Rieskie in his military uniform put on his VFW cap and explained the fact that the Post started as a Post of the Polar Bear Veterans Organization. Later he put on his SUVCW kepi and read McHale's Citation on capturing of a Confederate flag at Spotsylvania Court House. Rieskie then explained the significance of the flag in battle.

Cub Scout of Pack 4023 and Henry E. Plant Camp #3 Junior Member Richard Rieskie had the honor of unveiling the plaque during the ceremonies.

The whole event was filmed for showing on a local low power TV station. The camp also took a picture of the brothers present along with Medal of Honor recipient Duane Dewey surrounding the Muskegon County Medal of Honor Recipient plaque. Brother Rieskie hopes to get this picture in SUVCW's The Banner.

On Memorial Day Sunday Brothers Daniel Grable and Kenneth Kelly attended the Tri-Cities Memorial Worship Service held at St. John's Lutheran Church in Grand Haven. Kenneth Kelly is the Adjutant for the Grand Haven Memorial Day activities. The sermon was entitled "What Do We Remember? It was based on Deuteronomy 6:4-9 and the Minister talked about when and how the Bible tells us to remember God and Jesus and he connected it to the remembering of those military personnel that never returned from the wars the United States fought in.

The camp also participated in the Parade and Ceremonies in Spring Lake. Brothers Daniel Grable (American flag), Ronald Bellenger (Camp Flag) and Jonathan Scott (Color Guard) formed the color Guard for the entire Parade. They were followed by a group of Veterans with a portion riding their motorcycles along with Parade Marshall 90 year old World War II veteran Martin Czinder.

The parade went from downtown Spring Lake to the Spring Lake Cemetery where the Spring Lake Heritage Festival Committee conducted the local ceremonies with the Camp's assistance. After the introduction of Mr. Czinder the Camp flags were officially placed on the platform. On April 11<sup>th</sup>, the Traverse City Record Eagle newspaper began running a series of articles written by Loraine Anderson, a former Mayville classmate of PDC Rick Greene, about Traverse City's role during the Civil War.

Commander Aurand, Sec. Jenkins and Brother Jim Ribby traveled to Lansing to participate in the 'kick off' Civil War Sesquicentennial festivities on April 15th.

Camp 14 has been extremely busy throughout the month of May.

On May 7<sup>th</sup>, the long awaited grave dedication ceremony to honor Company 'K' warriors, John Jacko and William Isaacs was conducted under sunny skies. The ceremony commenced with the steady drumming and songs from the Grand Traverse Band Medicine Lodge Singers. Immediately following Cindy Patek and Doris Winslow performed their own tribute to their ancestor, John Jacko. Tom Jenkins, serving as Master of Ceremonies, welcomed family and friends of the veterans, as well as the Boyne City American Legion Post 22, and Peshawbetown's Eagletown Post 120. Representing the Dept of Michigan; Commander Don Shaw and Senior Vice Commander Dave Arnold were in attendance. Lt. Dean Lamphere and 6 members of the 14<sup>th</sup> Michigan SVR joined the Camp 14 Honor guards; under the command of Major Fred Leyh. Over 40 Brothers and associated order members participated, in addition to 100 descendents, tribal members and guests. Chris Czopek described his efforts to locate the graves of the veterans. He complimented the staff of the Boyne City Clerk's office who assisted him sorting thru the historical and Maple Lawn cemetery records until they successfully located the graves that had lain unmarked and forgotten for over a century. MC Jenkins turned the event over to CC Aurand, who ordered the bugle to sound the 'Attention' and for the GAR ceremony to commence.

Following the ceremony descendents and visitors alike stepped forward to compliment all of the participant's for their "professionalism, dedication and deeply moving presentation". Immediately following the GAR ceremony, Major Leyh and

Lt. Lamphere led the Honor Guard to the grave of William Isaacs, where Chris Czopek gave a brief description of Isaacs service, followed by a 3 volley salute and "*Taps*".

The May (14<sup>th</sup>) meeting was devoted to the 'After Action Report' of the Jacko-Isaacs ceremony. Everybody was very pleased with the complimentary coverage of the event by the Record Eagle and other community papers. We were informed that news of the ceremony had circulated to an even wider audience through the 'moccasin telegraph' via our new friends from Peshawbetown. Bill Skillman's topic was entitled: "Special Service-Civil War 'Snipers'-North and South". Bill described the various tactics developed by Civil War sharpshooters that have evolved into U.S. military sniper doctrine today. He showed an original 1858 target rifle with a telescopic sight (the same used by Union specialist-sharpshooters) and the various special tools needed to make it deadly out to 1000 yards. He then presented the Confederate's counterpart-a Whitworth rifle (imported from Great Britain and costing \$1000, only 36 were issued to the very best shots in the Army of Northern Virginia).

Despite \$4 a gallon gas, 6 Brothers drove to Lansing to participate in the 122nd Department Encampment on May 20–21. Delegates were Commander Dale Aurand, PCC Neal Breaugh, SVC George Goodrich, Secretary Tom Jenkins, and Brother Jerry Grieve. Commander Shaw appointed members to the Committees on Bylaws, Officers Reports, and Resolutions; Brother Skillman assisted PDC Gary Gibson on the Resolutions Committee. Camp 14 Brothers elected or appointed to Department Offices include CC Aurand (as Department Guide) and Sec. Tom Jenkins as Department Council member.

On Saturday May 28<sup>th</sup>, CC Aurand, Sec. Jenkins and Brother Jerry Grieve carried the National, State and Camp colors during the opening session of the National Soccer Administrators Conference at the Grand Traverse Resort. Each year the community devotes recognition of the veterans of one of America's wars who are buried at the Leelanau Township cemetery. This year's theme was the Civil War. Keynote speaker, Jerry Dennis, attired in a Confederate cap, (in honor of his Arkansas ancestors), did an excellent job of describing the economic and social pressures that finally dragged the country into armed conflict in 1861. He then provided a synopsis of the War through surrender of Robert E. Lee and the assassination of President Lincoln. Neal & Emily Breaugh, Dale & Lorraine Aurand, Tom Jenkins and Bill Watson manned the Camp 14 information tent; while Don Gray, Jim Ribby, Paul Timmerman and Chris Skillman comprised the Honor Guard.

I regret to inform you of the passing of another Michigan brother, 88 year-old Dr. Weldon Petz:

Dr. Weldon Petz. Weldon died April 28, 2011, in Farmington Hills, MI, after an extended illness. He is survived by his wife, Shirley, two children and four grandchildren. He was a member of the SUVCW by virtue of an uncle who was in the 5th NY Art. Band. The musical gene was passed down to Weldon who served in the 8th USAAC Special Services Band during WW II, then as a musician in the Jimmy Dorsey Band. He recorded with such notables as Ella Fitzgerald and Glen Miller.

Although a teacher and school principal in Farmington and Detroit, he as best known as an eminent Lincoln scholar, collector of Lincolnia, writer and lecturer. His enthusiastic stories about touring Michigan and collecting pictures and histories of Lincoln-related sites and monuments fascinated all who heard him speak. His efforts were put into book form in "Seeking Lincoln in Michigan" and "Michigan Remembers Lincoln". He donated his extensive collection of Lincoln memorabilia to the Plymouth Historical Museum prior to his death.

Brother Petz was a Life Member of Sgt. John S. Cosbey Camp No. 427, having transferred there after US Grant Camp No. 101 disbanded. He was also an Honorary Companion of MOLLUS. Interment took place May 3 in the Franklin (MI) Cemetery.
