

Winter has once again come to Michigan. As I write to you today, I look out the window at a gentle snowfall and note the crisp temperatures we are currently dealing with. I think back on quite a busy fall for the Department.

I have had the chance to visit with many of you in your home camps either this summer or this fall. In all instances, I found good men, doing the work that we as an Order do, keeping green the memory of the boys of 1861 to 1865. The ways you do this are as varied as there are men in the Department. From graves registration work, to monument dedications, to parades, to school presentations for the young, to genealogical research or helping someone find their own personal connection to the civil war, you have kept the faith with those who have gone before us in a dozen different ways. You are all to be commended for the work that we as a group have done.

A special way I have had in past years, and once again this year, of doing this work, is to participate with our brothers from around the Department in the services and parade at Gettysburg Pennsylvania on Remembrance Day. For those who do not know, Remembrance Day commemorates the address given at the dedication of the National Cemetery at Gettysburg, Pennsylvania by Abraham Lincoln. It is celebrated with parades, monument rededications, flag placement at the graves of the fallen, and services to honor the GAR and its' members. There is also the opportunity for camaraderie, education, exploring the National Battlefield, and a good time with your brothers. This year Michigan fielded a good sized delegation to this event.

One of the informal activities included the opportunity taken by some of your brothers to tour nearby battlefields with the assistance of a guide from the National Park Service. This activity, which has grown up over the past few years, gives you the chance to explore parts of our civil war heritage and see things up close that one normally doesn't get the chance to see and to hear in depth accounts of the battles that is generally not made available to the public at large. Held the Friday before, (Remembrance Day itself is on Saturday), you can take an entire day exploring civil war battlefields and doing things not readily available to the general public. This is just one aspect of the Remembrance Day weekend experience.

Another aspect starts close to dawn on

Remembrance Day. The members of the Department in attendance, place flags, both federal and state, on the graves of Michigan's fallen sons who are interred in the National Cemetery. These flags will remain in place until retrieved, before the sun sets on them, at the end of the day. As the day progresses, there will be participation by the Michigan Delegation in services at the Woolson Monument, remembering all the members of the Grand Army of the Republic, participation in the largest civil war parade in the world, and a special rededication of one of the monuments placed to honor the participation of the Michigan regiments that fought at Gettysburg. This year, we rededicated the monument to the First Michigan Infantry Regiment. (See photo).

1. On behalf of the Department, I offer thanks to all of the brothers of this Department who made the effort to honor our veterans on Veterans Day by participating in the several Veterans Day parades and activities around the state. I particularly want to thank those who answered the Department's call, and made the effort to participate in the Detroit Veterans Day Parade. Again this year, we had brothers who drove from all over the state to march together honoring Michigan's men and women who have served this country so faithfully in the armed forces. Such dedication to the Order and to the ideals we support led to another impressive display this year. This only happens because you brothers make it happen. Thanks you for taking the time to show your respect and support for our veterans in this way.
2. We are starting Camp Officer Installations around the state as of this writing. Most of you have already reserved time with me or another Department Officer to act as installing officer for your camp. If you are one of the few who has yet to do this, please contact me at once so we can be sure to have someone available to act as installing officer for your camp. I will personally take care of as many of these requests as I can. I do get double booked on occasion however, and in that instance, DSVC Dave Arnold has graciously offered to assist. Of course, as in past years, any camp requesting a special individual within the Order to do their installation will be accommodated if possible. Such requests still must be made through the Department Commander however so we can give your installing officer the authority he needs.
3. Our Department will be making a push to revitalize our Monuments and Memorials work. In recent years, the work done of checking on and cataloguing our Civil War Monuments around the state has come to a near halt. One of the charges of the Order in keeping green the memory would call on us to care for and inspect the monuments which in many cases the soldiers who fought the war erected. To that end, we have good people in place at the Department level to take in the information needed to start our Monuments program up again. We need committed people at the Camp level to serve in the role of Monuments and Memorials Officer. Presently, some of our camps don't fill this position. I ask each incoming Camp Commander to not only fill the position, but to fill it with a brother who will actively pursue the work of inspecting and reporting on monuments in your part of the state. A few hours a month is all we ask. If we can have that commitment from these brothers, eventually the work will be completed. To that end, if any brother has the hankering to act as his camps, "man in the field," please DO volunteer for this worthy work to your Camp Commander. If the project is to work, we need, "boots on the ground," going out to get this information. Your assistance in this regard is heartily encouraged.
4. All camps are reminded that the nationally mandated form 22, Certification of Election and Installation of Camp Officers should be ready at the time of your camps officer installation meeting so the installing officer may sign the same. Two copies must be mailed to the Department Secretary, Paul Davis. They are due to him no later than February 15, 2012. Copies of the form were contained in the Secretary's Kit that was distributed at the last Department Encampment. They may also be found on the internet at the National Web Site at <http://suvchw.org/ftp/form22fi/pdf>. 5. A new form is being required by the Department this year. Named form 22MI the purpose of the form is to keep our camp web pages up to date, make sure we have the correct person within the camp to whom the Michigan's Messenger is to be sent so as to ensure its delivery, and bring us into compliance with certain national policies regarding the internet.

The form is due at the same time as the regular form 22 that you must have in by February 15th and is to be sent to the same person as the other, namely the Department Secretary, Brother Davis. Copies of the form have been distributed to all of our camps but should you need another copy, please contact Brother Davis who will be able to send another out.

6. As long as we are discussing reports, Camp Patriotic Instructors are reminded that it is time to start thinking about filing out the reports that will go to the Department Patriotic Instructor, which he will then use in preparing a report for the National Patriotic Instructor. If you start working them up now, you will be able to get them in to Gary Granger, our Department Patriotic Instructor in plenty of time for him to compile his report. Copies of the form you should use are available on the National Web Site.
7. Brothers are encouraged to submit nominations for the Department's Abraham Lincoln Award. Each year the Department may award up to three of these awards to individuals, whether in the Sons or not, who have contributed to the public's awareness of the sacrifices of the soldiers and sailors of 61 to 65. The person you nominate should have their name and address, listed together with a description of why you believe they should be given this award. Nominations should be sent to Department Headquarters for transmittal to the Abraham Lincoln Awards Committee. That address is:

Greetings Department of Michigan Brothers and Camps:

As the holidays approach, I would like to take this opportunity to extend to each of you, and your families the **Warmest of Holiday Wishes.**

It has been a busy autumn for the Sons of Union Veterans of the Civil War. I would like to thank each of your Camps for your participation in Veterans Day activities in your local communities. The opportunity we have to honor our past and current service members as well as our Civil War ancestors is something we should express throughout the year as well as on Veterans Day. I would like to highlight a couple events that the Department has recently participated in.

On November 4th and 5th, 2011 camps from around the state participated in the Detroit Veterans Day Parade in downtown Detroit. This signature event marks the second year that the Department of Michigan, Sons of Union Veterans of the Civil War has chosen to commemorate the Civil War Sesquicentennial and honor our Civil War ancestors by marching in the parade. The weekend started out on Friday as the Historic Fort Wayne Coalition made overnight accommodations available to those marching in the parade, by opening up the "Historic Barracks" located at the Fort for us to stay in.. In the spirit of Fraternity, SUVCW members from around the state spent an evening of fellowship which culminated with a *Ghost Tour* of the Fort sponsored by the Historic Fort Wayne Coalition. On Saturday we car pooled from the Fort to our staging location for the parade. The weather was spectacular. We had a great contingent of camps and (55) brothers from around the state participated, as Camp Flags stretched across Woodward avenue. The 14th Michigan, Sons of Veterans Reserve color guard and Department of Michigan Commander, Don Shaw lead our unit. With the 102nd USCT reenactors providing the drummers and cadence. Members of the 7th Michigan, the 4th Michigan and the Sally Port Mess reenactors joined our contingent as well.

Participation in the parade continues to grow. A most impressive sight was the various members of the Detroit area Junior ROTC units from local high schools that marched in the parade. Dressed in their uniforms with black trench coats and campaign hats it was estimated that there were over a thousand high school students that participated. Their units went on for close to a half mile and made one think of what the Grand Review after the Civil War must have looked like.

On Saturday, November 12th, the Department of Michigan, Sons of Union Veterans of the Civil War participated in the second annual Civil War Sesquicentennial conference held at the State of Michigan Historical Center in Lansing. The conference was a consortium of private, historical, genealogy, reenactor and Civil War fraternal organizations that came together to share information regarding events that would be occurring in 2012 to celebrate the 2nd year of the Civil War Sesquicentennial. The Department of Michigan, Sons of Union Veterans of the Civil War set up a table display and shared our SUVCW events scheduled for 2012.

I would like to thank the camps and brothers that participated in both of these events. Secretary's Scribes

Since the last Department Encampment (May, 2011), we have provided all Camp Secretaries with the Department's Secretary Program, a matrix of the various Forms with their due dates, and a CD with the related electronic files.

Your Department Secretary has had contact with many of the Camp Secretaries and visited a number of Camps to gather feedback about the program and offer assistance to the Camps. It is noteworthy that the same program developed by the Department of Michigan has now been adopted by the National SUVCW beginning with this year's past National Encampment.

All Camp Commanders and Camp Secretaries should have received an Email communication by now concerning the Form 22 and the new Form 22MI.

The Form 22, Certification of Election and Installation of Camp Officers are the same and have the same requirements for completion as have been used previously. Be sure to use the most current fill-in version of the Form, 22fi .pdf. If you do not have the file, please download it from the National Sons of Union Veterans Website at:

What is new this year, however, is the requirement that the Form 22 must be completed fully before the Installation of Officers takes place. This includes the Camp EIN number (be sure it is complete and accurate) and all required signatures. The Form must be ready for the Installing Officer to add only his signature before he leaves your Camp at the time of the Installation.

There is a new Form designated Form 22MI, Camp Internet Information Form, and is for Michigan Camps only. This is not to be confused with the Form 22. The Form 22MI.pdf was emailed to all Camp Commanders and Secretaries. If you do not have the Form, please contact the Department Secretary and the file will be emailed to you. The Form 22MI.pdf is not an electronic fill-in form and may be completed legibly in hand writing.

The purpose of the Form 22MI is to gather and keep current contact information for Camp Officers for publication on the Department's website. Camp Officers have the right to decline publication of their contact information. If Camp Officers opt to have the information published, the Form 22MI provides space for an authorization signature.

Sons of Union Veterans of the Civil War

At the Civil War Muster at Cascades Falls Park, the Son of Union Veterans of the Civil War (SUVCW) is under the Rotary Band Shell. People stop by to see if they have any ancestors from Michigan who served in the Civil War. On the right side of the band shell people are learning and thanking the men of the Austin Blair Camp 7, Department of Michigan, SUVCW, the local camp in Jackson, for all of the help that they were given to find their ancestors. I wonder why people come to find out about and what their ancestors did in the Civil War, why they want to know where they are buried. The SUVCW organization works on helping men and women find their ancestors. To preserve the United States and offer our lives if need be, to recruit men who have an ancestor who fought for the Union, to honor Union Veterans, preserving and perpetuating the Grand Army of the Republic, and educate the kids in schools and the community.

In 2009, at the Civil War Muster, I started looking in to my past and my ancestor who fought in the Civil War. I join the local camp in Jackson, Michigan on January 11, 2010; I was the first new member of the year. I have studied more in depth the civil war over the past four years of my life. I have had an interest in the Civil War since sixth grade and have furthered my knowledge of the Civil War since then. I study the Civil War and a lot of the information I know is what I have taught myself.

The SUVCW has camps all over the continental United States. The men in the camp in Jackson help men and women find their ancestors at the Civil War Muster or at the Waterloo Farm Museum. Robert Griggs, past commander of the Austin Blair Camp No. 7, said that the SUVCW has "helped me gather more information about my ancestor and the men and women who fought to save the Union." Griggs has three ancestors two in the 12th Michigan Infantry, and one in the 4th Michigan Cavalry according to Members and Ancestors, a web page on Austin Blair Camp No. 7 web site. The camp has helped a lot of people and is still helping them.

The men in the SUVCW have a right to preserve the United States and not let the flag touch the ground. The brothers in the SUVCW in the invocation have to be able to lay down their life to preserve the United States. The article, "Introducing the Sons of Union Veterans of the Civil War," explains that prior to disbanding and before the death of its last member, the GAR officially designated the SUVCW as its successor and heir to its remaining property (Introducing). Griggs told me about the history of the SUVCW saying, "On August 20, 1954, the SUVCW was officially incorporated by an Act of Congress by the passing of Public Law 605 of the second session of the 83rd Congress." The SUVCW is post Grand Army of the Republic (GAR), which was founded in 1866 after the Civil War.

Every brother's job is to recruit men, who have an ancestor who fought for the Union into the SUVCW. Most of the men who join want to learn more about the Civil War. Griggs joined the SUVCW in October of 2002. "I joined because I wanted to learn more about my ancestors as well as the Civil War in general," said Griggs. To join a new member has to fill out application and give it to the local camp. At the camp's meeting they have to vote new members in. After being voted in the new member(s) go through initiation, and then after you are a member of the SUVCW you get the membership badge, which is pin to left side of member's shirt.

In the introduction article, the SUVCW have three main missions, the first one is honoring Union Veterans. Memorial Day (May 30) was first established by the GAR in 1868 (Introducing). The SUVCW goes out on that day to mark the graves of the Civil War Veterans.

The Austin Blair Camp No. 7 observes the care and upkeep of the Jackson Defense of the Flag Monument in the downtown Jackson at Withington Park, Wildwood Ave. at West Michigan Ave. The camp participates in the Memorial Day Parades in Jackson and Concord, Michigan.

The next mission is preserving and perpetuating the GAR. The SUVCW assists in the preservation and making available for research, the documents and records pertaining to the GAR and its members (Introducing). The meeting of the camp and the department and nation encampments are held in the same way that the GAR held theirs which are still conducted by the same tradition and rituals of the GAR. Austin Blair Camp No.7 follows the rituals, ceremonies and the tradition that the GAR used.

The last mission of the SUVCW is to educate the kids in schools and the community. The SUVCW has the patriotic education, which includes teaching patriotism and the duties of citizenship, the true history of our country, and the love and respect for our Flag (Introducing). Last May Austin Blair Camp No. 7 went to a middle school down in Adrian, Michigan and taught the kids about the Civil War. The Civil War Sesquicentennial is the biggest chance that the SUVCW will be able to teach eighth graders about the men in blue and gray. The SUVCW is already making preparations for the Civil War Sesquicentennial, which started on November 6, 2010, but the war started on April 12, which is the occasional start of the sesquicentennial.

The SUVCW has done a lot of things for many of people. Griggs said, "I enjoy it very much. I receive the most satisfaction from interacting with the public about the Civil War and telling them some of the stories that came from it. Also I get great satisfaction from finding and creating new links that I can put on the website that will allow more people to gather more information about our group and the American Civil War" (Griggs). The work done by the SUVCW will be around for a long time. I joined the SUVCW and found three ancestors that fought for the Union, two in the 20th Michigan Infantry and one in the 6th Michigan Cavalry. This year at the Civil War Muster, on Sunday, a man came up to the table and I helped him find out more about his ancestor, and after everything I did for him he was a happy man. I was very happy that I was able to locate where his ancestor was buried.

U.S. Grant Camp 67

Grant Camp Members Tour the Wilderness and Spotsylvania Battlefield Sites

Members from U.S. Grant Camp No. 67 visited the Wilderness and Spotsylvania Battlefields on a recent trip to Virginia. The tour began at Ellwood Manor, the summer home owned by the Lacy Family who also owned Chatham Hall located at Fredericksburg. During the Battle of the Wilderness, Ellwood was used as the Headquarters for General Warren.

The highlight of the tour for one of the Grant Camp brothers was the opportunity to honor the memory and walk the same ground where his ancestor fought and was wounded on May 6, 1864. A member of the 5th Michigan Infantry, Co. K, and John Haug was one of the lucky ones. He was wounded in the same area where many other wounded Union soldiers found themselves in even more danger due to the fires that were ignited during the battle.

11th Michigan Volunteer Infantry Reorganized

This is the 15th installment on this regimental history series. Rather than assign new numbers to newly raised regiments, Michigan had the bad habit of reorganizing disbanded regiments, giving the impression that far fewer units were provided by Michigan than actually were. This is yet another instance of this happening.

September 3, 1864, orders were issued to reorganize the 11th infantry under Col. W. L. Sloughton. Headquarters were finally established in Jackson in February of 1865. On March 4, four companies left for Nashville, Tennessee, followed by the rest of the regiment on the 18th under the command of Col. Patrick Kegan.

The regiment was assigned to 3rd Brigade, 2nd Separate Division, Army of the Cumberland, reporting to Gen. Steedman, commanding the District at Chattanooga. After three weeks, the regiment was stationed along the Chattanooga and Knoxville railroad on guard duty. They remained on this duty until August 3rd, when ordered to Nashville. Mustered out of service, they traveled to Jackson, where they were paid off and disbanded. The regiment had 1,140 officers and men, losing 81 to sickness and disease.


